The investment objective of Phillip Global Qualty Fund is to seek medium to long term total return for the investors. The Sub-Fund will invest all or substantially all of its assets in the GMO Underlying Fund, namely GMO Quality Investment Fund.

A high quality company is generally one that the GMO Underlying Fund Manager believes has an established business that will deliver a high level of return on past investments and that will utilise cash flows in the future by making investments with potential for high levels of return on capital or by returning cash to shareholders through dividends, share buybacks, or other mechanisms.

The equity securities in which the GMO Underlying Fund may invest shall include, without limitation, common stocks, depositary receipts (ADRs, EDRs or GDRs) and related securities such as convertibles, preferred stocks, income trusts, royalty trusts, MLPs, ETFs, REITs, private placements, rights and warrants.

Currently, Class SGD Dis (Z Class) and Class SGD Hedged Dis (ZH Class) Units of Phillip Global Quality Fund are being offered.
